TERMS & CONDITIONS

1. Trade stand applicants **MUST** carry appropriate Public Liability Insurance and must provide proof of such within this application. Please note that bookings cannot be confirmed without this proof.
2. Applicants must provide the name and number for a show day contact for use by the Trade Stand Secretary if necessary.
3. Trade stand set up is restricted to Saturday 25th of June or show day. All stands must be set up by 8.30am. No trade stand to be taken down before 4.30pm on the show day. Earlier set up by arrangement with the Trade Stand secretary.
4. Strictly no vehicle movements are allowed on the showground after 8.30am on the show day or before 5.00pm.
5. The pitch sizes **MUST** include all guy ropes, towbars and vehicles etc. Please note that the show is held in an agricultural field and the ground may be uneven in places. Therefore, the condition of the pitches offered cannot be guaranteed.
6. The show will not provide any power to trade stands. A small **QUIET** generator is permitted.
7. Please consider very carefully how you complete the section in the form describing your stand and what you intend to sell. It is very important that you complete this section fully so as to avoid having two stands close to each other selling the same items. If you fail to mention an item on your booking form which you subsequently offer for sale, you may be asked to withdraw that item from your stand.
8. Dangerous Items – It is forbidden to sell (or give away) guns, knives, catapults, weapons or any item that the Trade Stand Secretary considers may cause offence or danger to members of the public. This includes toys and replica items. Please contact the Trade Stand Secretary if clarification is required.
9. The Society shall accept no liability whatsoever for any losses suffered by the applicants in the event that Malton Show is cancelled, or if there shall be any alteration to its date or venue at short notice or otherwise.
10. The committee reserves absolute discretion in all matters relating to the above and the siting and activities of all trade stands on show day.
