MALTON SHOW – TRADE STAND TERMS & CONDITIONS

1. Trade stand applicants **MUST carry appropriate Public Liability Insurance** and must provide proof of such with this application, booking will not be confirmed without this proof.

2. Applicants must provide the name and number for a show day contact for use by the Trade Stand Secretary if necessary.

3. Trade stand set up is restricted to the day before the show (Saturday) or show day. All stands must be set up by 8.30am at which point all vehicles must be removed from the site. Dismantling can take place from 4.30pm onwards. Strictly no vehicle movements are allowed on the showground after 8.30am and before 5.00pm on show day.

4. Pitch sizes MUST include all guy ropes, towbars and vehicles etc. Please note that the show is held in an agricultural field and the ground may be uneven in places. Therefore, the condition of the pitches offered cannot be guaranteed.

5. Generator hire is available from the show committee, please contact the office for booking details. If you provide your own equipment, only small, quiet generators are allowed on Trade Stands and respect must be shown to other exhibitors. All electrical and gas equipment must conform with relevant current legislative safety regulations.

6. Please consider very carefully how you complete the section in the form describing your stand and what you intend to sell. It is very important that you complete this section fully to avoid us having two stands, close to each other selling the same items. If you fail to mention an item on your booking form which you subsequently offer for sale, you may be asked to withdraw the item from your stand. **No hot food or alcohol for consumption on the Showground can be sold from Trade Stands**.

7. Dangerous items—it is forbidden to sell (or give away) guns, knives, catapults, weapons or any items that the Trade Stand Secretary considers may cause offense or danger to members of the public. This includes toys and replica items. Please contact the Trade Stand Secretary if clarification is required.

8. Overnight camping on the Saturday prior to the show day is available through this application form ONLY. No camping will be allowed without prior booking.

9. We are pleased to offer **FREE Wi-Fi** to all trade stands at this year's show, we will be working hard to ensure coverage for all stands and accept no responsibility for the level of cover.

10. The Society shall accept no liability whatsoever for any losses suffered by the applicants in the event that Malton Show is cancelled, or if there shall be any alteration to its date or venue at short notice or otherwise.

11. Whist we endeavour to re-sell any cancelled trade stand space, no refunds can be guaranteed.

12. The committee reserves absolute discretion in all matters relating to the above and the siting and activities of all trade stands on show day.

N.B. We are asking all trade stands if they would be willing to offer exclusive discounts / a free gift to our members. Please note there is no obligation for any stand to do this. The quoted price of the stand would remain the same.
